



ENROLLMENT AGREEMENT

I hereby enroll my child at Turning Pointe Dance Center (TPDC) for the "Dance Season" beginning on Monday, September 14th, 2026, and ending in June 2027 (July 2027 for team members). I have read and agreed to all policies, terms and conditions as stated in Turning Pointe literature including, but not limited to tuition rates and payments, costume payments, dress codes, class placement, general recital information, etc. All this information can be found on our website www.turningpointedancecenter.com as well as the Policies section of your online parent portal.

I understand that by submitting my registration for the 2026-2027 Dance Season, my credit card will be charged for tuition and a \$25 registration fee, to complete my registration.

NO REFUND POLICY

If I chose to withdraw my child from the program at any time during the dance season, I agree to notify TPDC in writing prior to the next tuition installment charge date (1st of the month), or the next installment will be due. Until the written notification is received, a spot will be held in the class, and tuition will continue to be charged. Tuition is not refundable. There are also no refunds on costumes, competition fees, etc.

In the event my child withdraws from dance class prior to the start of the dance season or anytime during the season, I acknowledge that there are no refunds as a spot has been held for my child. If we ask your child to leave TPDC for poor behavior, bullying, or any other reason TPDC staff deem appropriate, there will be no refunds for tuition, costumes, competition fees, etc.

PERFORMANCES, LIABILITY, PHOTO RIGHTS

By allowing my child to participate in Turning Pointe Dance Center's 2026-27 season, I hereby release, waive, discharge, agree to hold harmless and covenant not to sue Turning Pointe Dance Center (TPDC) for any illness or injury incurred to the child or parent/guardian during these events. The undersigned hereby agrees to follow the guidelines and procedures provided. The undersigned fully understands the risks inherent in dance activities and agrees to indemnify and hold harmless TPDC, its directors, officers, employees, volunteers and agents, and each of them from any loss, liability, damages, or costs the undersigned may incur whether caused by the negligence active or passive, or otherwise while the undersigned or any participating child is in, upon or about the premises of the studio or any TPDC event. Therefore, the undersigned releases the Turning Pointe Dance Center and its staff from all legal liability and medical costs arising due to any injury incurred during instruction or participation in any TPDC related activities/performance.

The undersigned further releases rights to all photos/videos taken in relation to Turning Pointe Dance Center for exclusive TPDC use in promotion or advertising. I have read and understand the terms of this Assumption of Risk, Release, and Waiver of Liability, and Indemnity Agreement and agree to its terms.

PAYMENTS AND FEES POLICY

I understand that tuition and registration payments are due prior to classes starting and that no invoices will be mailed to my home.

Tuition for the 2026-2027 dance year can be paid upfront prior to the start of classes or split into 10 equal installments. If you choose our installment plan, your first payment at registration will consist of 3 months of tuition (first and last two). Tuition will be due on the 1st of each month. All cards will automatically be charged at this time. If you prefer to pay by cash or check, you may do so before the 10th of the month. If you choose not to have your card set up for autopay, it is your responsibility to make payments in a timely manner. TPDC does not send out monthly bills.



Credit card fee: A 3.5% fee will be added when using a credit card. This excludes initial registration payment along with reoccurring online monthly auto payments.

There are no refunds for missed classes; makeup classes can be scheduled. Tuition is calculated based on the full dance season, with holidays already factored in. It is divided into 10 equal monthly installments, regardless of the number of weeks each month. There is a built-in tuition discount for students that take multiple classes and families with siblings enrolled at TPDC.

I also acknowledge that a \$15 late fee will be applied to payments made after the tenth of each month. There will be no refunds given. The registration fee is non-refundable.

A \$40 fee will also be applied to all returned bank checks. After the 2nd returned check, I understand that TPDC will require only cash payments going forward. I also acknowledge that if my account is delinquent for more than 30 days and/or my child has excessive tardiness or absences, it may result in my child being dropped from dance classes entirely. This decision will be at the discretion of Turning Pointe Dance Center management.

COSTUMES

A costume fee per dance will be applied to all accounts October 10th. Costume prices are dependent on classes. (Competition solos may vary in price depending on custom costume options) Payment is due on November 1st. **Accounts MUST be in good standing for costumes to go home.**

RECITAL PACKAGE

A \$65 recital fee per account will be charged to all accounts in the spring, prior to the show. This fee includes a Recital T-shirt (to be worn over costume in the finale), livestream access (for up to 5 devices), professional photography, and professional videography of our shows. For families that have more than one dancer, an additional \$20 will be charged per dancer for the recital T-shirt only. This charge will occur on/or around May 1st.
